#### FHWA Changes Policy And Broadens Application Of Buy America Act To Manufactured Steel Or Iron Items And Miscellaneous Steel Or Iron Products

Due to a recent Court decision, the FHWA has rescinded a 2012 policy exempting manufactured items that were at least 90 percent steel or iron, and other miscellaneous steel and iron products, from the Buy America requirements. This action broadens the range of steel and iron products that are subject to Buy America Act (BAA) requirements for Federal Aid Highway projects.

In an Order dated December 22, 2015, the U.S. District Court for the District of Columbia vacated an FHWA 2012 Policy Memorandum creating exceptions to the "Buy America" requirements for use of domestic steel and iron on federally funded highway programs. The 2012 Memorandum exempted manufactured items that were at least 90 percent steel or iron, and other miscellaneous steel and iron products, from the BAA requirements.

The Buy America preference requirement is grounded in several evolutions of the Federal Surface Transportation Assistance Act. One aspect of the related acts was the preference for domestic unmanufactured and manufactured products purchased with federal highway funds. Those preferences included domestic steel and iron products, both manufactured and unmanufactured.

However, the acts allowed the Secretary of the U.S. Department of Transportation to exempt materials and products from the Buy America requirements when the Secretary deemed Buy America compliance would be inconsistent with the public interest. Using his exemption authority, in the 2012 Memorandum, the Secretary exempted from Buy America policy application two categories of products: 1) manufactured products made up of less than 90 percent steel or iron; and 2) miscellaneous or "off-the-shelf" steel or iron products. The case before the District Court involved a legal challenge to those policy exemptions.

The court agreed with the challenging plaintiffs and held the 2012 Memorandum violated the federal Administrative Procedures Act (APA) because: a) the 90 percent threshold had not been subjected to required notice and comment rulemaking processes, and was itself arbitrary and capricious; and b) the miscellaneous products exceptions likewise were not subjected to required notice and comment rulemaking processes under the APA and also for BAA waivers.

Thus far, the FWHA has not issued any additional clarification regarding Buy America implementation, nor has it initiated any related rulemaking processes. The overall impacts remain to be seen, but pending any overturning of the decision on appeal, or such rulemaking processes, all steel and iron products for federally funded highway projects must be reviewed for compliance with the Buy America requirements, and potential exemptions.

#### General Assembly Considers Over 2,000 Bills

The 2016 session of the Virginia General Assembly is in full swing. Over the next six weeks lawmakers will consider over 2,000 pieces of legislation. VTCA is actively engaged in lobbying on more than 50 bills that impact our members. Below is a highlight of several of the key bills in which we are engaged. Watch for VTCA's electronic General Assembly Updates to get a full listing of bills and updates on bills as they move through the legislative process.

#### HB 501 Request for Proposal; design-build transportation projects

Allows for the submission and consideration of alternative technical concepts, defined in the bill, during the Request for Proposal process of a design-build transportation project.

#### HB 578 Virginia Public Procurement Act; architects and engineers services, etc.

Provides that for architectural or engineering services, the public body shall not request or require offerors to list any exceptions to proposed contractual terms and conditions until after the qualified offerors are ranked.

#### HB 796 Practical design standards; VDOT to employ standards for any highway system project

Requires the Department of Transportation to employ practical design standards for any highway system project, including all projects costing more than \$5 million. "Practical design standards" are defined in the bill as standards that incorporate maximum flexibility in application of standards that reduce the cost of project delivery while preserving and enhancing safety and mobility.

#### HB 1069 Tolling civil penalties; period of nonpayment; limitations on tolling; notification of violations

The bill prohibits tolling any highway, bridge, or tunnel without approval of the General Assembly except in limited circumstances. The bill requires the Department of Transportation to allow E-ZPass account holders to provide an email or phone number and to electronically notify account holders of a toll violation and further requires toll operators to notify the Department of such toll violations. The bill amends the definition of high-occupancy toll (HOT) lanes to ensure that mass transit vehicles and commuter buses meet the high-occupancy requirement. The bill lengthens from 30 to 60 days the period following notification of an unpaid toll on HOT lanes after which, if the toll is still unpaid, the owner or operator of the vehicle is in violation. The bill decreases the civil penalties for an unpaid toll violation on the HOT lanes, making them equal to civil penalties for other toll violations, and allows the HOT lanes operator to offer reduced civil penalties if the owner of the vehicle pays within 14 days prior to the hearing date, which is also permitted for other toll operators. For violations on any toll road, the bill provides that for a first court appearance there are reduced civil penalties and places a cap of \$2,200 on civil penalties and administrative fees. Finally, the bill provides for a 10-day grace period for unpaid tolls and requires toll operators to attempt to process and collect unpaid tolls twice during such period.

#### HB 1108 Virginia Public Procurement Act (VPPA) and contracting generally; use of experience modification

Prohibits the use of any experience modification factor as a condition of any bidder's or offeror's eligibility to participate in a solicitation for construction services. The bill includes the above provision for any contract or offer to contract not covered by the VPPA. The bill also provides that it applies to any offer to contract as defined in the bill, Invitation to Bid, or Request for Proposal for construction services issued on or after July 1, 2016. The bill defines "experience modification factor."

#### LEGISLATIVE UPDATE

#### General Assembly Considers Over 2,000 Bills (Continued)

#### HB 1169 Mineral mining; bonding program; reclamation

Grants the Commonwealth a lien on land reclaimed by the Director of the Division of Mines, Minerals and Energy (the Director) for the amount of the increase in the value of former mining land that results from the reclamation of the land. The bill increases the amount of the reclamation bond that a mine operator must pay from a range of between \$200 and \$1,000 per acre to \$3,000 per acre and provides procedures related to the operation of the lien, including procedures for perfection, waiver, recordation, priority, amount determination, and satisfaction. The bill also modifies the existing Minerals Reclamation Fund (the Fund), establishing it as a non-lapsing revolving fund with a minimum size of \$2 million. Current law sets the Fund's floor at \$250,000 and does not prevent moneys in the Fund from reverting to the general fund at the end of each biennium.

#### SB 311 Virginia Public Procurement Act; use of best value contracting, construction & professional service

Authorizes any public body to procure construction on a best value procurement basis. Under the bill, if proceeding on a best value procurement basis, the Request for Proposal must contain a notice to potential offerors that the procurement decision will be made on a best value procurement basis and describe (i) the criteria that will be considered in evaluating the proposals and (ii) the rating or weighting system that will be used in evaluating the proposals, including a disclosure that price will be weighted at least 51 percent as a factor.

#### **SB 470** Motor vehicle fuels sales tax in certain transportation districts

Motor vehicle fuels sales tax in certain transportation districts. Increases the tax on the sales price charged by a distributor for fuels sold to a retail dealer in Hampton Roads from 2.1% to 5.1%.

#### VTCA Contractor Safety Awards Program

Contractor Safety Award submissions are due by February 29. Winners will be announced and awards presented at VTCA's Spring Transportation Construction Conference on April 7.

### VTCA Aggregate Producers Meet With VDOT

One of the issues identified at the last VTCA/VDOT Co-Op meeting was the growing imbalance of fines within the aggregate market. The meeting, attended by VDOT's Deputy Chief Engineer Mohammad Mirshahi, focused on a number of areas suitable for additional research which could benefit both VTCA and VDOT, including:

- Fines in Shoulder Stone
- Manufactured Sand specification revisions to allow more fines
- Additional quarry by-products utilizing fines
- Increasing fines in CTA

As a result of the Co-Op meeting, several small working groups were created. These include VDOT and industry personnel. Several have already met, with promising results.

#### Spring Smoke Schools Coming In March

VTCA's Visible Emissions Certification Classes ("Smoke Schools") are scheduled for March 18 in Roanoke, March 19 in Abingdon and March 21 in Richmond.

Anyone involved in taking visible emissions readings is required by the Environmental Protection Agency to receive certification every six months.

You may receive a reminder from Compliance Assurance Associates (CAA) regarding your registration for these classes. These reminders are automatically generated 90, 30 and 15 days out from the classes to everyone in their database holding a certification, whether you are already registered with VTCA or not.

This is only meant as a reminder from CAA which conducts the schools.
